Preparation of this Plan

Progress Against Target for Emissions Footprint

BFBS formally committed to becoming a net zero carbon emissions organisation by 2050 or sooner in 2021/22 and since then we have assessed, monitored and reported on our greenhouse gas emissions in line with the Streamlined Energy and Carbon Reporting regulations (SECR).


Data has been collected from invoicing and other reporting provided by our suppliers and also from information directly extracted from our financial accounting system. The conversion factors applied to this data to assess the emissions were taken from "Greenhouse gas reporting: conversion factors" published by the Department for Business, Energy & Industrial Strategy.

Although overall emissions increased in 2024/25, there are several positive indicators to demonstrate that the rate of increase has slowed. The main headline being that the carbon intensity ratio per employee has decreased, from 3,189 to 3,170, no doubt as a consequence of the environmental initiatives and awareness which has been embedded within the business over recent years.

Another significant improvement is that air travel emissions reduced by 7%, despite an increase in the overall headcount. Further emission reductions are expected to continue in the future as we look to implement changes to our travel policy, an appointment of a new travel supplier, whilst maintaining the controls over our travel footprint.

Elsewhere, we also recorded reductions with our employee commuting and to a lesser, but still important, extent, with our waste emissions. This can be attributed to our Environmental Management System which was introduced as part of our successful accreditation to ISO 14001.

The following graphically depicts the current progress against target for the reduction of Carbon Footprint by BFBS and is current at the date of this plan.
